Since the United States Supreme Court rendered its decision in *Almeida-Sanchez v. United States*, fixed border patrol checkpoints have been operated under authority of temporary "probable cause" warrants issued by a "neutral and detached" Federal Magistrate. The author analyzes the constitutionality of this practice in view of recent decisions and concludes that the procedure is consistent with opinions expressed by a majority of Supreme Court Justices.
